The BeSMART Home Loan Program provides financing to improve the efficiency and comfort of your home. **You may qualify for up to \$30,000 in financing at a rate of 4.99%.**

Who is Eligible?

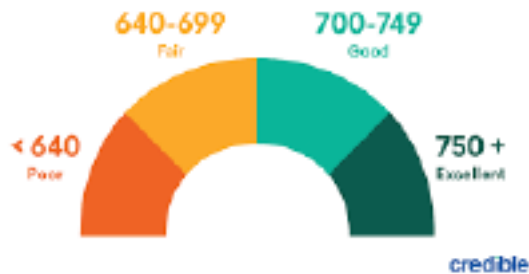
Maryland homeowners who meet the following eligibility standards:

- Credit score of 640 or greater
- Debt-to-income ratio that does not exceed 50%

The BeSMART loan is an unsecured loan based on verification of credit and ability to pay.

What are the requirements?

- Submission of an application with all required income documentation



BeSmart Home Loan Terms

Amount	Rate	Term
\$30,000 (Maximum) \$5,000 (minimum loan)	6.99% (APR 6.99)	10 Years

Example: Homeowner installs insulation, completes air sealing, and replaces their furnace with ENERGY STAR equipment.

VALUE OF LOAN: \$10,000
MONTHLY PAYMENTS: \$116

ELIGIBLE ENERGY SAVING MEASURES

- Insulation and air sealing
- ENERGY STAR® heating and cooling systems
- ENERGY STAR hot water heating equipment
- ENERGY STAR appliances, roofing, windows, doors
- Lighting and controls
- Programmable and smart thermostats
- Ceiling fans and ventilation fans
- Geothermal heat pumps
- (Limited) solar photovoltaic
- Health and safety costs related to energy improvements
- Other improvements identified in a certified energy audit

How do I get a BeSMART Home Loan?

- 1. SUBMIT AN APPLICATION:**
BeSMART Home application and financial documentation; Certified energy audit; Scope of work, contractor estimates, ENERGY STAR® equipment specifications
- 2. GET APPROVED.**
- 3. COMPLETE YOUR PROJECT:** The project kicks off with an initial draw of funds to start work.
